Beethoven, Symphony No. 7: Mvt 1, mm 84-110, mm 430-end of mvt AND Mvt 3, mm 181-234 (no repeat)

Beethoven, Symphony No. 8: Mvt 3, mm 45-end of mvt (with repeat)

Beethoven, Symphony No. 9 (4<sup>th</sup> Horn): Mvt 3, mm 83-121 (with pick-up)

Mahler, Symphony No. 1: Mvt 1, 4mm before Reh 2 to 1m after Reh 3 AND Mvt 3, 4mm after Reh 13 to Reh 15

Prokofiev, Romeo and Juliet: Romeo at Grave of Juliet, Reh 59 to Reh 62

Shostakovich, Symphony No. 5: Mvt 1, 3mm after Reh 17 to 1m after Reh 21

Strauss, Don Juan: 17mm before Letter O to 9mm after Letter O

Strauss, Don Quixote (4<sup>th</sup> Horn): Variations 7 & 8

Strauss, Ein Heldenleben: 4mm after Reh 3 to 2mm after Reh 5, 1m before Reh 78 to 2mm after Reh 79

Tchaikovsky, Symphony No. 4: Mvt 1, beginning to 6mm after Letter A

Wagner, Gotterdammerung, Act 2, Scene 2: 22 mm before 8 to 8.

Musicians are responsible for providing their own music.

Please be prepared to sight read.

There is a possible ensemble round.

Contract may be contingent on a successful performance of a concert series.

If a principal position is won by a current FCS member, that section vacancy may be filled.
